

2022 Summer Meetings New Rule Proposals

Deadline – July 16th, 2022

9 Total Votes Received = 7 owners, 1 commissioner & 1 secretary. (5 owners did not vote.)

Issue – Website Administration

The following proposals are aimed in improving league finances

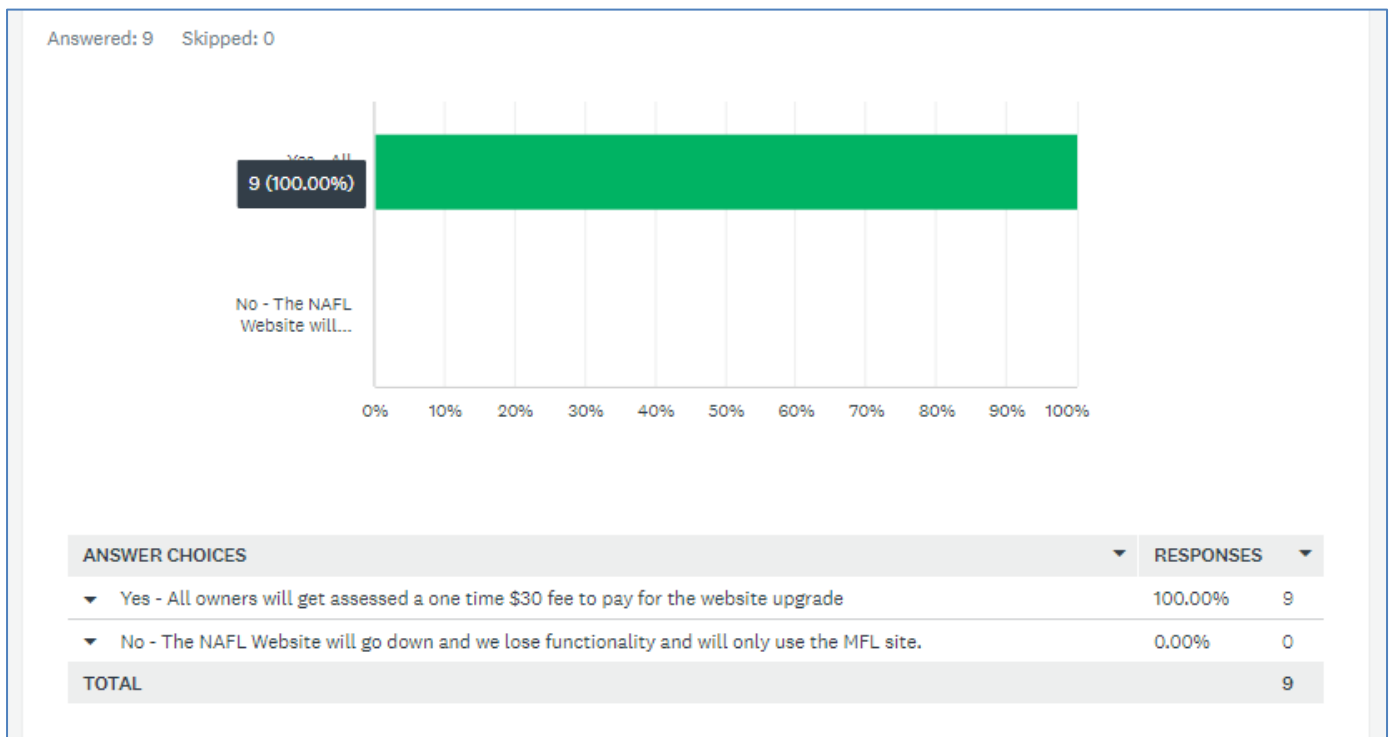
Proposal A – Assess All Owners a fee to pay for Website Upgrade – **Passed 9 – 0**

We need to assess all owners \$30 per owner to pay for a Website Upgrade of \$300.

Our designer has told the NAFL that we need to upgrade the NAFL website otherwise the site will go down. We have a sweet deal (Since our designer and web host is my wife) where we do not pay her normal hosting and update charge of \$240 a year and normally she charges \$800 for the upgrade. So even in paying the \$300, we are still ahead by over \$740!

If we decide not to assess owners the \$30 the NAFL Website will go down and we will only use the MFL site. In going solely with the MFL we do lose functionality, especially during the off-season, such as Summer Meetings, League Payment Portal, Keeper page, Draft page, Prize Money or winnings pages, NAFL History, NAFL Records, NAFL Awards pages and a one stop portal for both the NAFL and VFF leagues. Most fantasy football sites do not support these activities. Some of these pages you may or may not use but they are a part of the NAFL experience.

- **A Yes Vote = All owners will get assessed a one-time \$30 fee to pay for the website upgrade. 9 votes**
- **A No Vote = The NAFL Website will go down and we lose functionality and will only use the MFL site. 0 votes**



Issue – Finances

The following proposals are aimed in improving league finances

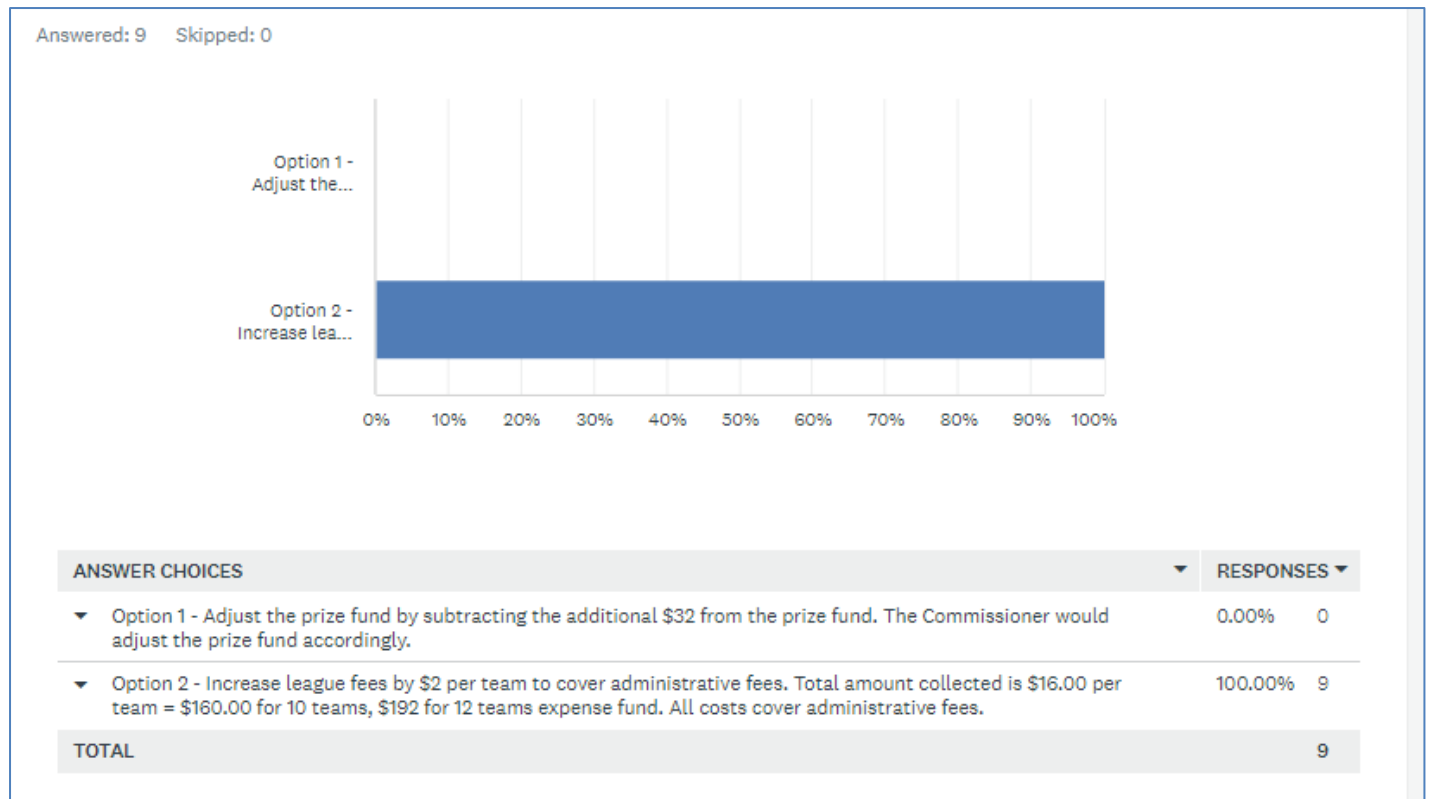
Proposal B – Update Administrative Expense Fund - Option 2 PASSED – 9 votes

Due to price increases for our administrative expenses finances need to be updated. Below are two options on how you want to pay for administrative fees we incur year. Here are our current expense structure we foresee this year.

- Website Expense = \$32
- MFL Website = \$90
- PayPal Fees = \$20
- Shaw Webhosting = \$20
- Trophy plate = \$30
- Total needed = \$192

The current admin fee is \$168 so we need to increase by \$32.

- **Option 1** – Adjust the prize fund by subtracting the additional \$32 from the prize fund. The Commissioner would adjust the prize fund accordingly. **0 votes**
- **Option 2** - – Increase league fees by \$2 per team to cover administrative fees. Total amount collected is \$16.00 per team = \$160.00 for 10 teams, \$192 for 12 teams expense fund. All costs cover administrative fees. **- 9 votes**



Proposal C – Update Prize Fund **Option 3 PASSED – 4 votes**

Due to the longer regular season in adding an extra week league finances need to be updated as shown below.

The proposal is to update the Post-Season Pool to one of the below options due to the change:

- Option 1 **-2 votes** - Do not increase fees. Lower prize fund amounts by \$69 for a total fund of \$542. Prize fund would change as follows:

CHAMPION-\$165

RUNNER-UP-\$70

The 3rd – 8th place money will be reduced by \$5 each.

- Option 2 – 1 vote - Increase league fees by \$3 thereby creating a post-season fund of \$578. Prize fund would change as follows:

The 3rd – 8th place money will be reduced by \$5 each.

- Option 3 – 4 votes - Increase league fees \$5 to thereby creating a post-season fund of \$602. Prize fund would change as follows:

The 8th place money will be reduced by \$5 each. - PASSED

- Option 4 - 2 votes- Increase the prize fund by \$10 to thereby creating a post-season fund of \$662. Prize fund would change as follows:

3rd Place – \$55

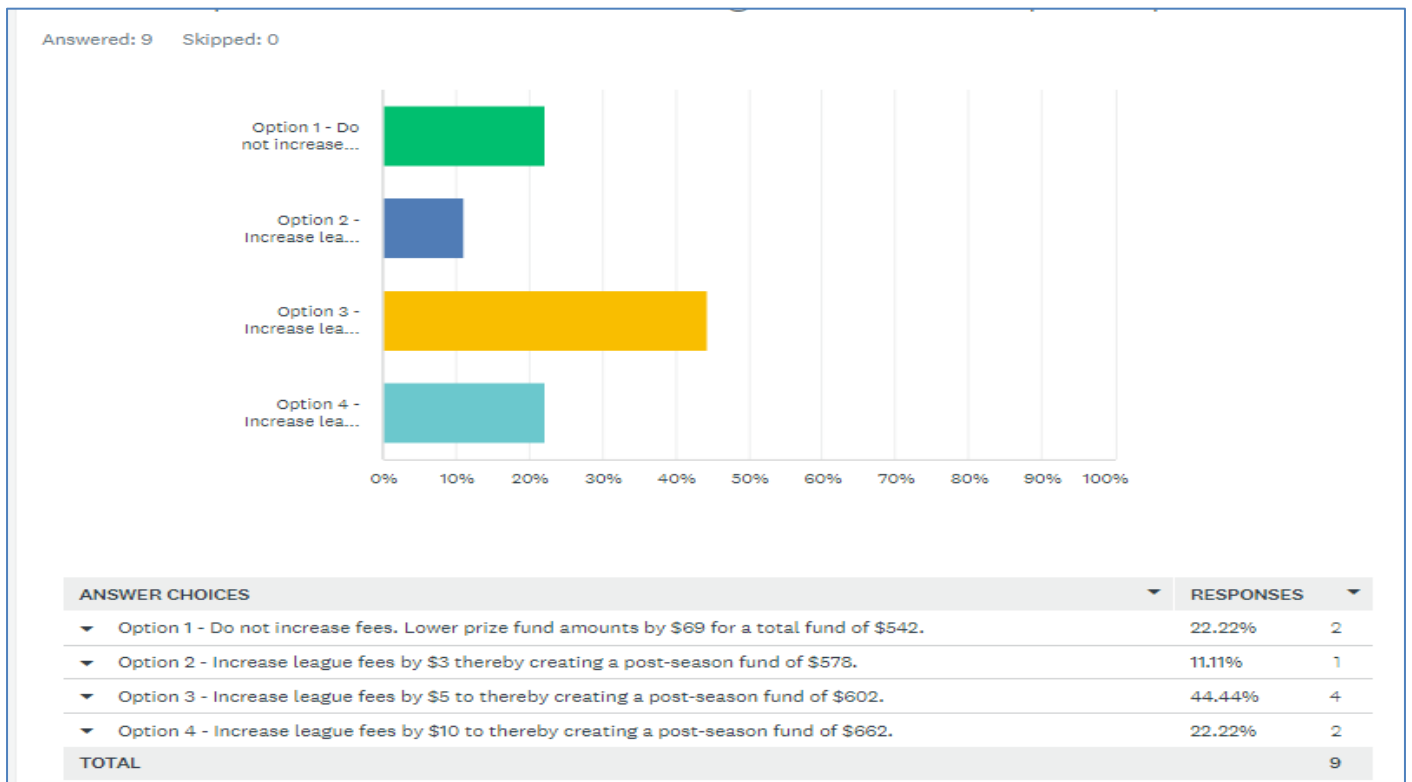

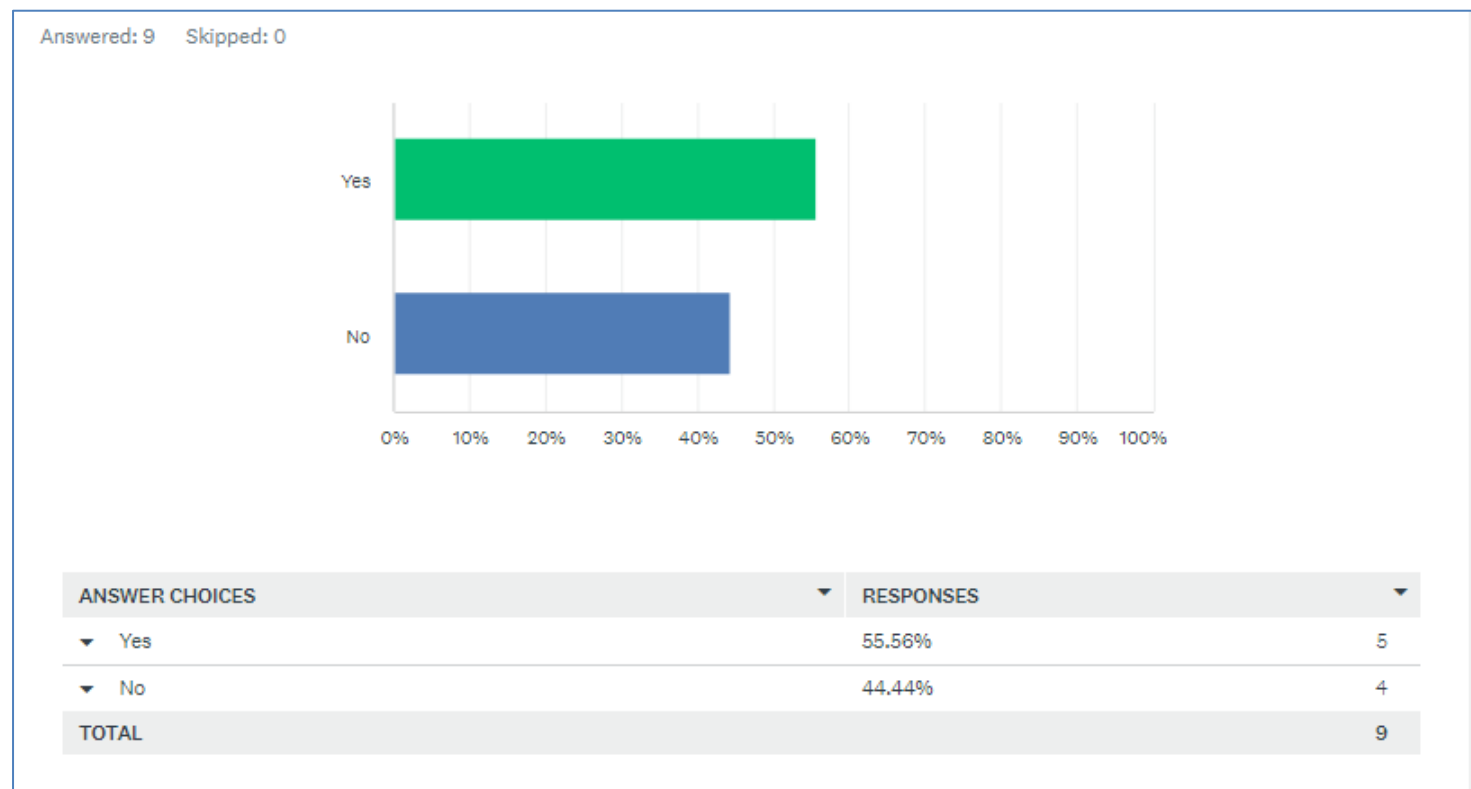


Issue – Competition

The following proposals are aimed to improve competition.

Proposal D – Expand NAFL Playoffs – PASSED 5-4

Expand the NAFL playoffs by one week. Add two wildcard teams to the playoffs so 10 teams make the playoffs. Week 15 would be the wildcard round, where the last 4 teams play to face off against the #1 and #2 seeds in week 14. All other teams get a bye week in week 15. Playoffs would run from week 15 to week 18.



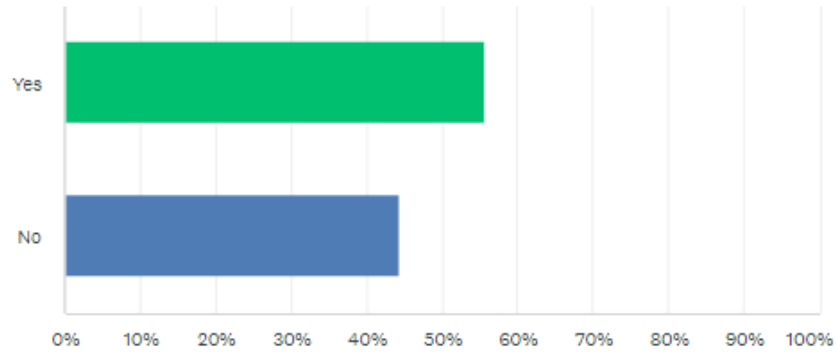
Issue – Draft

The following proposals are aimed to improve the draft and make selecting QB's fairer.

Proposal E – Selection of Third QB – Passed 5-4

To make it fair for everyone to have two quality QB's, a team's 3rd QB is not allowed to be selected until the last round of the player draft. The round before head coaches and are selected. This includes QB's that are kept as a keeper. This allows every team to have 2 quality QB's on the roster and does not allow teams to hoard QB's on their roster.

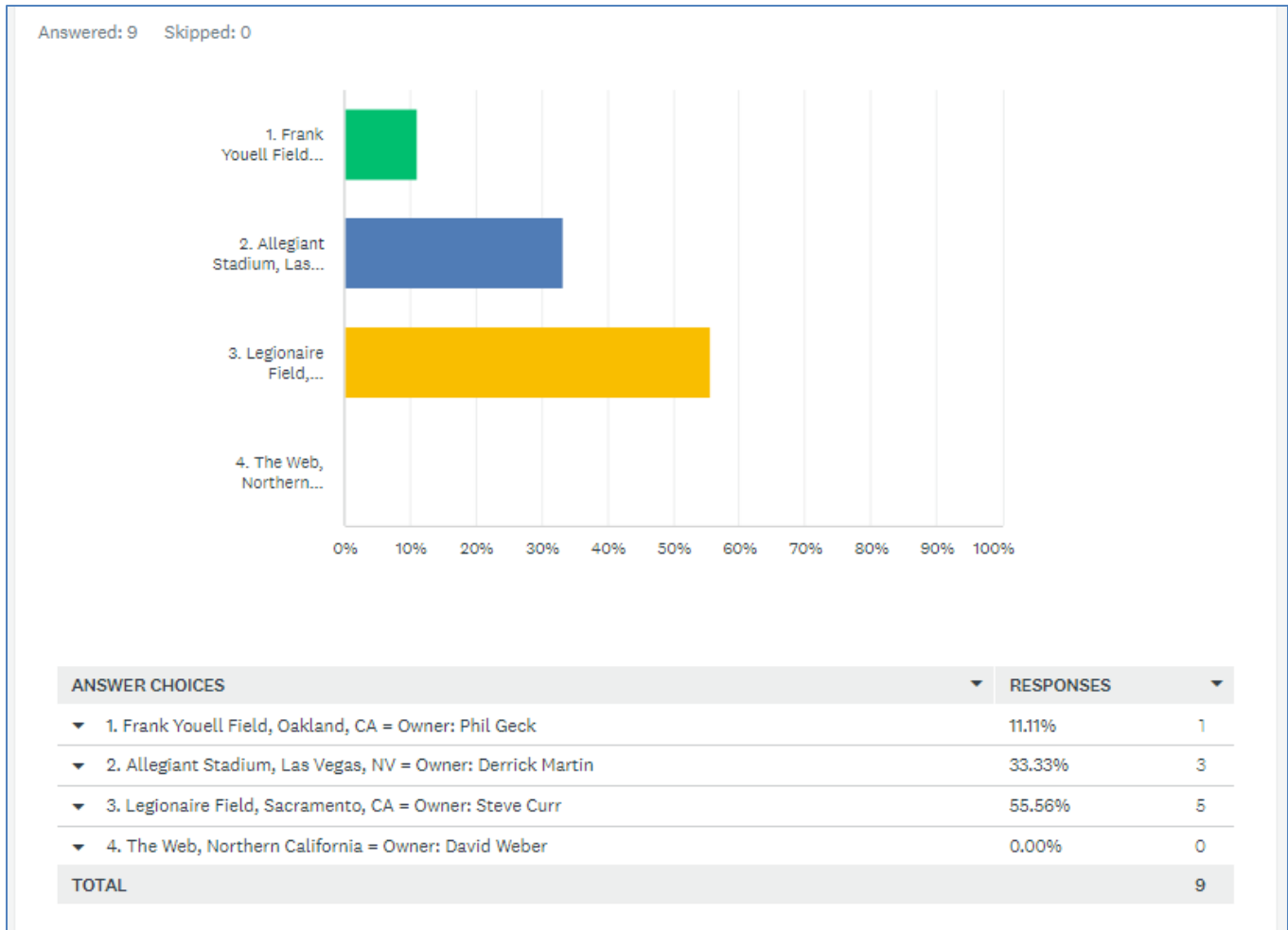
Issue – Season Activities and League Operations

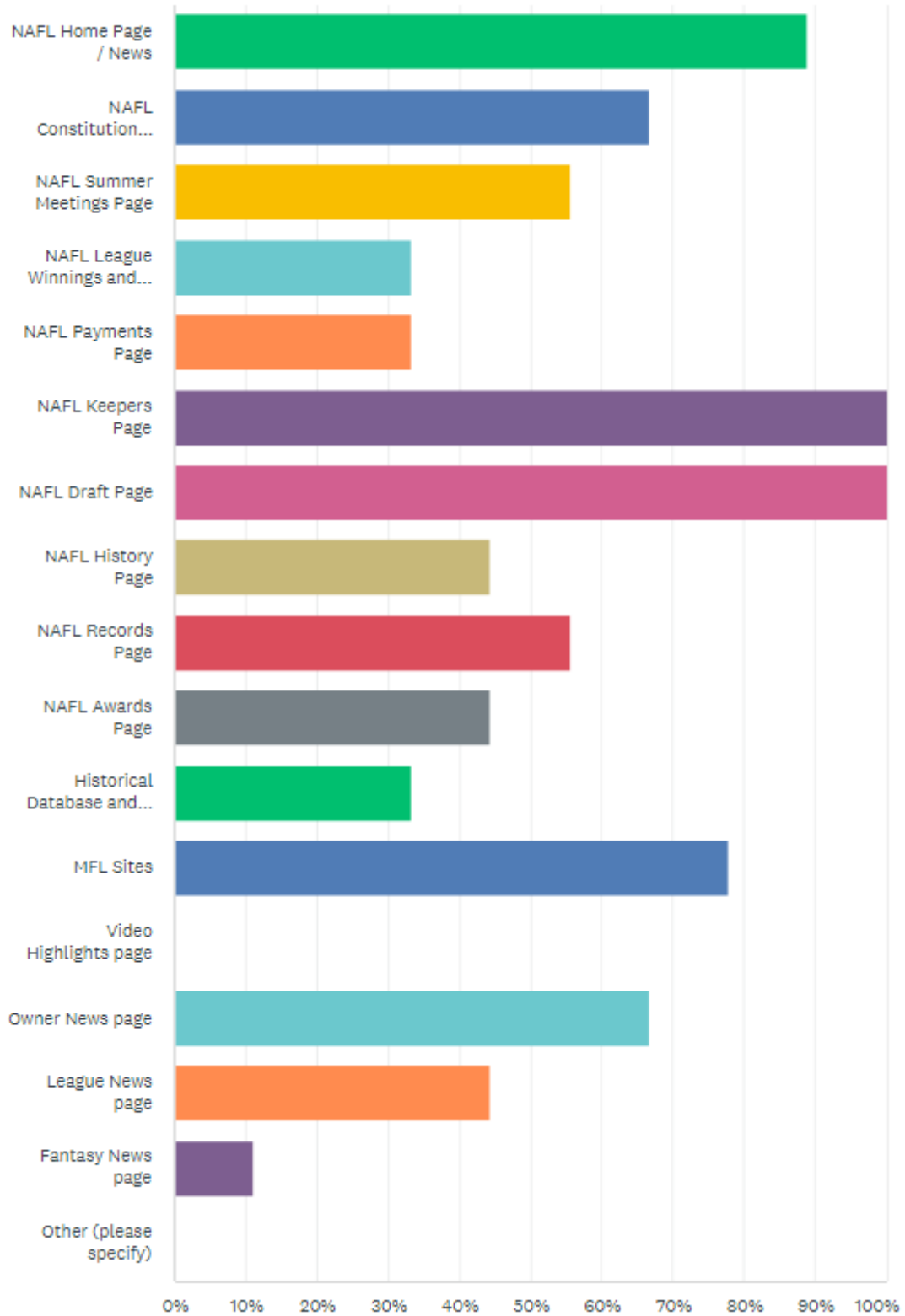
